GENERAL SUPERVISION IS RECEIVED FROM A HIGHER LEVEL LIBRARIAN OR ADMINISTRATIVE DIRECTOR. SUPERVISION IS EXERCISED OVER THE WORK OF PROFESSIONAL, PARA-PROFESSIONAL, CLERICAL, AND VOLUNTEER STAFF. DOES RELATED WORK AS REQUIRED.

THE TRAINING AND EXPERIENCE QUESTIONNAIRE WILL BE AVAILABLE ON **MAY 1, 2011**, AND APPROVED CANDIDATES WILL BE REQUIRED TO COMPLETE AND SUBMIT THIS QUESTIONNAIRE. CANDIDATES WILL BE ADDED TO THE ELIGIBLE LIST IN THE ORDER IN WHICH QUESTIONNAIRES WERE COMPLETED AND SCORED. **NOTE:** CANDIDATES MAY BE CREDITED WITH TRAINING AND EXPERIENCE GAINED UP TO THE DATE THE TRAINING AND EXPERIENCE QUESTIONNAIRE WAS SUBMITTED.
