The Position

The Schenectady County Clerk is currently recruiting Motor Vehicle Representatives* for the Schenectady County Department of Motor Vehicles Office. This position assists drivers in renewing their licenses and vehicle registrations or applying for driving permits and photo identification cards. Motor Vehicle Representatives also receive and process various New York State Motor Vehicle forms ensuring that information is properly documented with great care and attention to detail.

**This position is part of the NYS Helps Program, and an exam will not be required.*

Qualifications

Candidates must possess the following minimum qualifications to be considered:

- A. Graduation from a regionally accredited or New York State registered two year college or university with an Associate's Degree in Accounting, Business Administration or a related field; OR
- B. Graduation from high school or possession of a high school equivalency diploma, plus two (2) years of experience as a teller, cashier, payroll clerk, accounting clerk or other appropriate experience that involved the handling of cash; OR
- C. Four years experience as outlined in (A) above

SPECIAL REQUIREMENT: Employment is contingent upon citizenship verification and a criminal background check sufficient for issuance of Enhanced Drivers Licenses (EDL's) or identification cards.

Salary

The annual salary for this position starts at \$47,971.
